FIRST STATEMENT OF VIJU WORTLEY

---

I, VIJU WORTLEY of Mala, Sandy Lane, Pamber Heath, Hampshire RG26 2PA will say as follows:-

1. I am the Applicant in these Proceedings and I make this Statement in support of my application for a Non-Molestation Order.
2. The Respondent is my older sister and we both grew up in India. It was apparent to me from a young age that she had emotional difficulties. When I was around 10 or 11 years old my mother sent the Respondent to live with my grandmother as she simply could not cope with the Respondent's behaviour.
3. When I was 16 I became aware that the Respondent was having psychiatric treatment. The Respondent would commonly start screaming and shouting for prolonged periods for no apparent reason. I recall on one occasion after I had received excellent exam results that the Respondent set fire to the curtains in the house. The Respondent was studying for a degree at the time but was unable to continue because of her state of mind.

4. When I was 18 the Respondent and I moved to the United Kingdom with my parents, as my father had been seconded here for 2 years by his employer. I now understand from my parents that this move was an attempt by them to find better help for the Respondent who was then aged 22. The Respondent started undergoing psychotherapy and became a resident in a specialist care unit in Manchester, whilst she was also studying at university.
5. When my father's secondment concluded after 2 years my sister and my parents returned to India and I stayed in England to complete my university degree. My parents later returned to live in England permanently.
6. I had almost no contact with my sister after she returned to India. I am aware that she left India and went to Arizona and Wisconsin to undertake a post-graduate degree, but I believe she was unable to complete her studies. She then went to a Canadian University but again I believe she could not complete her studies and then returned to America.
7. However the Respondent had returned to America illegally and was arrested. She remained in US custody for a number of years as she refused to provide them with the information they required to deport her. Eventually she was deported by US officials.
8. The Respondent, who was by then in her 40s returned to England in 2006 and married an Englishman.
9. After having not seen the Respondent for almost 25 years and having had very little contact she suddenly turned up at my home in 2006. She told me that she could not have children of her own and therefore my children were her family now. She insisted on seeing them, however given her previous behaviour I told her that I did not want her to have contact with my children, who were only 5 and 8 at that time. The Respondent however refused to listen and tried to telephone us on numerous occasions and sent us extremely disturbing letters.
10. Over the next 4 years the Respondent sent numerous abusive letters to me and my husband. We hoped that the Respondent would just give up and leave us alone. However in 2010 she stole my mother's phonebook which contained the mobile telephone numbers for me, my husband and the children as well as our email

- addresses. The Respondent also stole a photo album which contained pictures of my children.
11. Shortly after the above incident the Respondent left us a threatening voicemail at 2 o'clock in the morning saying, 'I know where your kids are!' I was extremely frightened by this and feared for the safety of my family. I therefore telephoned the police who informed social services. We also changed my children's mobile telephone numbers. Despite this the Respondent continued to send us abusive text messages.
  12. The Respondent then published the photos which she had stolen from my mother on a website with our names and our address. The website contains pages and pages of rants about me and my parents, as well other people whom I do not know.
  13. I continued to get abusive letters and text messages over the next couple of years which I tried to ignore. One of the text messages said "When Steve Wortley [my husband] shoots cum up Viju's cunt he is killing me'. I have shown this message to the police. There is now produced and shown to me at pages 1 to 10 of the exhibit marked "VW1" copies of several abusive emails received from the Respondent.
  14. In 2012 the harassment intensified and my sister created an email account that appeared as though emails were being sent from my husband's work email address. The Respondent impersonated my husband and sent abusive and racist emails to people that she believed were his work colleagues. She also signed my husband up to the BNP and the American Nazi party. We reported this incident to police who provided us with an incident number.
  15. In October 2012 the Respondent left me a voicemail saying that she had been to my daughter's school, but was unsure if it was in fact the correct the school. She said that she wanted to see the kids. Fortunately the Respondent had gone to the wrong school, however I contacted the police and told them that she was trying to find my children. A few days later the Respondent left me another voicemail telling me that no one, not the police or social services, would stop her from seeing her niece and nephew. It appeared from some of the letters that the Respondent sent that she may have been receiving treatment from Hillingdon Hospital or the Pembroke Centre.
  16. On or around the 13<sup>th</sup> December 2012 the Respondent turned up at my home a few days before my son's birthday. She told me that she wanted to see him. I explained to

her again that I did not want her to have contact with my children. The Respondent would not listen and she again went to my parents' house and managed to obtain my children's email addresses and mobile telephone numbers from my mother's Ipad. The Respondent then contacted the children directly. This was extremely frightening and upsetting for us all. The Respondent was relentless and would not leave my family alone. She was determined to have contact with my children and at the same time try and destroy my family.

17. The Respondent's behaviour continued and at the end of February 2013 the Respondent hand delivered a note that said, 'stop trying to kill me.' It was very disturbing and this note could easily have been read by one of the children. The Respondent then turned up the following weekend at my house dressed as a nun and I again asked her to leave us alone.
18. The Respondent's behaviour has again worsened and she has managed to find out which school my daughter attends. The Respondent emailed the school on the 6<sup>th</sup> March 2013 pretending to be me, by again creating a fake email address. The Respondent stated in the email that my daughter had self-esteem issues and therefore she wanted to come into the school. The school assumed that it was me and therefore responded to her. There is now produced and shown to me at page 11 of the exhibit marked "VW1" a copy of the email sent to the school by the Respondent.
19. On Monday 11<sup>th</sup> March 2013 the Respondent went to my daughter's school wearing a fancy dress nun's habit over her normal clothes. Fortunately the school intervened and contacted the police. I also telephoned the police to report the incident and inform them of the Respondent's recent behaviour.
20. The Respondent was then contacted by Police Constable Hammond who spoke with her about her behaviour. However PC Hammond could not take any formal action as the Respondent was on this occasion not judged fit to be interviewed.
21. On Friday 19<sup>th</sup> April 2013 I received two voicemails that I believe are from the Respondent. The first voicemail was received at 15:47 and stated, "Viju, I will fuck your head". The second voicemail was received at 15:50 in which the Respondent screamed, "Viju, I will kill you". I received a further dictated message on Tuesday 23<sup>rd</sup> April 2013 at 9:09 which said, "Viju you are world famous. Everyone thinks you are a

bitch". On the same day my husband also received some emails from some unsuitable organisations that we believe the Respondent must have signed him up to, which is something that she had done previously.

22. On or around the 25<sup>th</sup> April 2013 the Respondent was arrested and due to appear in Basingstoke Magistrates Court on the 9<sup>th</sup> May 2013. The Respondent has been released on bail and her bail conditions are as follows:-
- i) Not to contact directly or indirectly or via their places of work or education, Viju Wortley, her partner Stephen Wortley or their children.
  - ii) Not to enter Hampshire except to enter court or pre-arranged appointments with the solicitor.
  - iii) Report to Ruislip Police Station everyday between 11:00am and 12:00pm.
  - iv) To live and sleep each night at her home address.
23. I am concerned that the Respondent may try and hurt me, my husband or my children. I believe that there is a risk that she may try and kidnap the children. The Respondent's attempts to have contact with the children are escalating and her behaviour is erratic and unpredictable. She has a long history of mental health issues and her harassment of me and my family for the last circa 6 years is becoming increasingly serious. I have recently spoken to the Police and they have advised me to obtain an injunction against the Respondent to protect me and my family. I am very concerned as to how the Respondent will react if she were to have notice of this application.
24. My family are living in fear and I would therefore ask the Honourable Court to grant me an Injunction to protect me and the children.
25. Further given the real danger of the Respondent attempting to take the children from their schools or even from my care I seek a provision in the Injunction that the Respondent be forbidden from entering Hampshire in line with her bail conditions with the same exceptions as well as coming within the area outlined on the map exhibited to this Statement and now produced and shown to me at page 12 of the exhibit marked 'VW1'.
26. The Respondent lives in South Ruislip and has absolutely no reason to come into Hampshire (save for the exceptions included in her bail conditions) or within the area

outlined on the map. My children use public transport to get to and from school and this involves travelling through Hampshire to the area outlined on the map. I therefore believe it is essential for the children's safety that there is no area in which the Respondent could come into contact with them when they are travelling alone and are vulnerable.

27. Further while the Respondent is already aware of which school my daughter attends she does not yet know which school my son attends. I believe it is vital that this information is not disclosed to the Respondent and therefore the area outlined on the map needs to be relatively substantial so as to not give away the position of my son's school.
28. I would ask that the Honourable Court grant me an Injunction on the above terms until further order so as to protect me and my family. I would also ask that the return date be listed for a date after the Respondent's Court hearing in relation to the criminal proceedings at Basingstoke Magistrates Court on the 9<sup>th</sup> May 2013.

...y the environment.

...subjected to sexual assault by parents using either Indian nationals or female bodies and through, as nobody else is as willing to stalk me as they want

...to get out of this country, for now want a holiday from my parents. The Home Office have when I am expressly forbidden from having a boyfriend when on UK soil.

They have written if I want to carry on a relationship with Alex McDowell, I can do so long-distance from India,, or he can settle in India to carry on with me.

The Home Office has written I am so intelligent I can find a job even on Mars (effectively) I can go back to India as I don't need these elaborate facilities that support womens weaknesses in the United Kingdom such agencies.

You see even though agencies are open to everyone, you often find people of only one race working/ as service users.

What happens is, only women "work" in agencies, and only women are service users, to be honest.

The point is, in the absence of agencies, these women would have achieved many things by leaning on a man, but now they walk "equal" supported by agencies and achieve the same things, without men as this support is provided by the state, in the form of groups of women who have been given bundles of leaflets.
