Dear Mohini

Thank you for your query, received on 26 February 2024.

We are sorry to hear about the difficulties you have been facing, trying to find out whether your father is still alive. Unfortunately, this isn't something Liberty will be able to help with. This is because we can only give information on areas of the law that we have expertise in, and unfortunately your situation isn't one of those areas.

If you are worried about your father's welfare, you can report this to your father's local police force in the UK, which appears to be Thames Valley Police (as his GP is registered in Reading). You can also request the police to carry out a welfare check for your father. You can find out how to contact Thames Valley Police via their website: <https://www.thamesvalley.police.uk/>

You have told us that this has had a significant impact on your mental health - if you are having thoughts of hurting yourself or ending your life and you feel like you can't keep yourself safe, you should call the emergency services or go to your local A&E.

Your Original Message:

Dear Madam, My name is Mohini Hersom. I am attaching a bank statement and two pieces of identification to explain who I am. My father normally lives alone in the UK, Since my mother died in February 2022. I was not allowed to attend her funeral due to immigration barriers. In late 2022 and 2023 I was refused a visitor VISA to the United Kingdom. I don't want to make an unnecessary visa application. When I make an application I want to include new information which will have the approval of a solicitor who feels my prospects have improved for getting a visa My father has completed 90 years of age in January 2024 and since then he has been deteriorating. He is very dear and he is a very intelligent 90 year old. But with breathing difficulties and hardly able to speak he can't do very much. He resides in the home of my sister off and on, when he is not well enough to take care of himself. My sister has a trumped-up criminal conviction against me which she got in 2013. The name of this conviction is harassment without violence. Trumped-up convictions are very rare and the courts are normally just and want to seek the truth. Also, some guilty people lie that they are innocent. Naturally people might not believe me that I did not do any of the alleged, and that is not the focus of this matter. Unless a conviction like that is overturned by the courts there is nothing to do about it. Viju Wortley has an injunction against me from 2013. It would be up to her discretion to withdraw the injunction. But when my father was stronger she told him she would never withdraw the injunction for life. According to my father, Viju's husband Stephen Wortley was suspended temporarily in 2012 from the Atomic Weapons Establishment awe.co.uk at Aldermaston where he is a senior scientist. According to my father, who I don't believe would lie, Stephen Wortley told him that the Atomic Weapons Establishment would not tell him why he was suspended. He was then allegedly re-instated, and the Atomic Weapons Establishment gave him the first name and last name of my boyfriend in London who allegedly is behind the emails received by the Atomic Weapons Establishment. Emails were sent to Steve apparently which were intercepted by the establishment and they found them to be coming from a racist organization. Naturally we don't know which bits of the story are true ,but I can tell you my boyfriend didn't do it. My father told me Viju decided to trump up a case against me, rather than have any further trouble at the Atomic Weapons Establishment. Lawyers had told me at the time that the conviction was petty in nature and did not warrant deportation, especially as a prison sentence was not given. I feel that there is still evidence that the Wortleys made up tales about me, and it would be nice if some lawyer could phone Atomic Weapons Establishment and ask them if they have anything against my boyfriend or me on their records. If they don't , Steve was making the whole thing up. That is a legal matter. But on this day,26 March 2024 I do not know if my father is alive or not. When he deteriorates he goes and lives with Viju rather than alone in his five bedroom house. Daddy's voice is almost inaudible and sounds like wind moving through a pipe. He has stopped answering the phone. One possibility is that he has declined considerably. The other that he is intimidated and brainwashed by his captors who are now physically and mentally stronger than him which would be to not answer the phone. If my father dies, Viju won't be kind enough to let me know, and she says that nobody should contact her to get the message. She will allegedly prosecute me if I asked through a friend about father's welfare. Now I don't think that's possible but the threat is certainly there and maybe I need a lawyer. The Basingstoke police said that unless I state that my father's safety is at risk in my sister's house, they refuse to do a live-and-well check. It's not their job, they said. I am sure he is morally and physically intimidated to be aloof to me and it may be in his best interest not to answer the phone when I call for his own personal safety I want to ask the doctor if they can release information to me if I prove that I am his Daughter Getting a lawyer for love or money is not a straightforward matter. They want thousands of pounds to start a conversation, and it's not possible to establish which area of law it belongs to. I've also tried the Mayor of Tadley and Tadley church. I've not been able to get a lawyer. They counselor at my father's borough, Mr Biyi Oloko was the most helpful and he said ask the local Citizens Advice Bureau what to do under the circumstances. My father is registered at Theale Medical Practice, whose senior partner physicians are Dr. and Dr Mrs. Rock. The medical secretary says she can't tell me if he's alive or dead because I'm not allowed to contact my sister. A secretary doesn't know that much and I am only not allowed to contact my sister there is no restriction on contacting anybody else.b so my father has not given authority nor has he said it must be kept private from me so I'm going to apply as I feel he's not in a position to give authority. He's physically and mentally under the control of the manipulative lady and the two of them (according to me) don't have any limit to what all lies they can tell. Anyway if I prove that I'm his daughter I should have a right to know what's going on with him I found a very close friend of my late mother living next door to my parents but she is not picking up the phone My father said on the phone on 14th March that he was in a taxi going to his GP. He didn't answer phone calls for three consecutive days which was 18 19 20 the March at which point I discovered this lady friend of my mother living next door at 18 Carston Grove, but she's not picking up her landline phone. My father's voice is very hollow since he started to stay with my sister again recently and I think he's not able to speak. He answered yes, to whether

he seriously ill and he staying with Viju because he is not well enough to live alone. Yesterday there was no answer from Dad and today it's coming out unavailable It's not fair that I can't see Daddy and I also can't know about his condition. I don't know what to do why am I supposed to live with this. I want euthanasia with worldwide publicity if this matter cannot be resolved I cannot say for sure but do not feel the Irish government can stop it.
