I also consulted the Basingstoke police over needing an update on my father as my sister does not let him use the phone at least to call me. Police said it was a matter for social services as there was no allegation of risk of bodily harm and social services, who are not abusive, are taking forever to respond.

If you did not understand why I am such isolated shunned scum to be treated as I deserve now you know

I do not have great legal and political acumen and no talent in telling lies. I just speak my mind and er- face the consequences.
