Dear Ms. Gillian Williams

My name is Mohini Hersom. I have spoken today with 0300 555 1386 to one Kim Jones, after talking to Councillor Kevin Chatburn, who wants to help me. Kim has provided your name as her boss. She believes that I should at least get an emailed response. My phone number is +44 7706 554261 and my Whatsapp is +353 899 640 562, and I can be called or messaged here. I am able to provide identification and other messages exchanged proving I am the daughter of Mr Krishna Swami Venkataramanan.

Kim Jones advised me she is not allowed to share information about my father, Mr Krishna Swami Venkataramanan, who's date of birth is 18th January 1934. His official residence is 19 Carston Grove, Ford's Farm, Calcot, Reading, RG31 7zn. He is living with my sister Viju Wortley and her husband, Steve of the Atomic Weapons Establishment at Mala, Sandy Lane, Pamber Heath, RG26 3PA. But if he is too unwell, he could have been admitted to hospital or nursing home stay. I think this is not likely but need to know how he is getting on. A Christian pastor found out that Krishna was alive in the first week of June 2024, but that his condition has deteriorated.

Since March 2024, my father has answered his phone and Whatsapp. The last time he was on the phone is when he confirmed he was seriously ill and after that he stopped picking up the phone. his voice was very cracked and I do believe he was and continues to be seriously ill. All along without Viju breathing down his neck, Krishna is sweet like a baby. When she looms large he starts to act as she wants. Just because you do not have dementia does not mean you are in control of your free will. I am his family and should attend at his bedside. I cant expect a lot of functional intelligence from a person of that age and condition, even if he is smart. Can you be smart when you are struggling to breathe? I can't! He is being smart by doing as she says. Its best for his safety and well-being.

My boyfriend in London phoned Steve at work at Atomic Weapons to ask how Krishna was, and Steve apparently answered F*** you, this info is secret.

According to Kim Jones, it is against the law to let me have any information about my father. the reason she gave is that my father has not given written consent to for me to know about him. if I want to know anything to do with that family I have to contact that family.

My sister had a trumped up conviction against me in 2013, it was a petty one called harassment without violence. these things get spent in 5 years but she got an injunction not to contact her, but this injunction only applies to my sister, her husband her two kids. This injunction does not apply to our common father Krishna. He did not live with Viju until recently, and he and my mother Radha who died in 2022, lived at their own home, not in Hants. They did not participate in Vijus conviction which was from created stories without producing any evidence and not even coming to court.

It is not illegal for me to contact Krishna. If Viju Wortley tells you it is illegal for me to contact Krishna, remember she is an opponent and cannot be expected to stick to the truth.

In April 2024 Viju has signed a refusal of registered post addressed to Krishna, which would probably be a class 3 felony in the United States, to not give parties their mail.

I should certainly have a right to know if my father is alive and should be able to pass messages to and from from him.

This is extremely cruel so kindly elucidate the law that makes you withhold info as total secret from me. Do you agree with Kim Jones belief this is indeed the law, and can you provide information about this law? Who instructed you my fathers life and death matters should be secret?

Getting someone's legal or medical records requires their official consent. Getting info on how someone is doing is not controlled by such a law. Did Krishna himself ask that his whereabouts and how he is going should be secret? I seriously doubt he would not done so if Viju was not breathing down his neck, such as being in the room. I told Krishna how Steve was behaving saying to my friend Fuck you this information is secret. Krishna failed to understand we were checking if he was alive. Krishna's safety should be protected from Vijus hate, and at the same time be allowed to speak to me on his phone. His safety comes first with me.
