This letter is a once-in-a-lifetime event. More like something that happens once in a century than once a year. Now, I believe that once something is given to you, it becomes yours. Whereas I am still its author, and sent it so you read it.

If you do not want to read it, I request you give it someone else who might. The worst thing you could do to this letter is to post it to Viju Wortley without keeping a copy. The second worst is to chuck it in the wastebin without keeping a copy.

Please act with a conscience over what you may (justifiably) feel is none of your business. I should say act with compassion, not a conscience. I am not running from any police government or home office. This letter contains NO DIRT, no secrets. My name and address will appear at the back of every signed dated numbered page.

For example, Viju scanned a signed dated letter I wrote her to PC and removed my signature and date and told police I am mentally unstable and write her anonymous letters. I NEVER write to anyone anonymously. I am sure you are not the same as my wayward sibling, but annoying as I may be, there is no sneakiness or covert action.

I am writing to you because you are a neighbor of my father Mr Venkataramanan of 19 Carston Grove. Sending registered post gave me the peace of mind as I will know the addressee picked up the letter, if nothing else. I am also sure you will be relieved to learn my first letter to you is also my last. Unless you solicit further communications. My contact details and (free) Whatsapp are above.

I'm writing to ask you to can speak to Mr Venkataramanan on 07757 491 353 please tell him I'm giving him my love. He doesn't pick it up since March and I at this point I don't know if he's in a condition to answer the phone.

I've been in touch with the church who are wonderful people. Around Easter, I tried the landline number of my father's other immediate neighbor, Agnes Slade several times and wrote her snail mail without response.

You told me she may have gone away for the Easter break but she will be back.

I think Agnes is a very close friend of my parents KV and Radha

I think Radha might have given her a reward for taking care of her. That's why Agnes, who lives in the next block became their neighbour. I think Agnes who is the same age as me and Viju Wortley feels like a sibling to us. I think Agnes feels sibling rivalry and wants to lean on the stronger side. I prefer not to contact her as I think she is not willing to respond.

I would like you to speak directly to my father IF POSSIBLE and tell him I am giving him my love.

I think you know the situation with my family. Viju will not inform me if my father dies. While this is ruthless and shocking behaviour, I am aghast to think the entire

UK is on the war path and want me emotionally deprived. British offices are doing me a cruelty they would not do to any of their murderers.

Surely the Home Office would not stoop down to such a low level as telling offices to "run from me" and suppress info and suppress the secret that my fathers health condition is top secret. I feel this hate and deprivation campaign against me is a national one rather than a domestic dispute between me and Mrs Viju Wortley.

Liberty wrote back saying they don't have the legal expertise to advise on this matter. I think Liberty are lying.

People are running (disappearing) in offices when asked how my father is. If there was a law to keep his life and well-being a secret - which there isn't - they would be able to say so. No need to run dodge and lie.

There is no law against me contacting my father. My parents are not party to the trumped-up criminal conviction of July 2013 of myself by Viju Wortley called "harassment without violence". My parents lived at 19 Carston Grove. Viju has been living 6-12 miles away in Pamber Heath Tadley all along.

Accessing someone's medical or other official records requires their authorization. If they are not well enough to give authorization access to their records can be litigated. That is an expensive legal matter not relevant to my purpose. I just wanted to know how my Dad is doing. That does not need official and legal clearance.

Along with the conviction of 2013, which was trumped up, Viju Wortley has an injunction which she plans to keep for life.

It's not an exaggeration that the allegations (with no proof) used to get the conviction were completely bogus. But that's not important.

It's not right that Mr Venkataramanan can give authorization, because he is very old, physically helpless and under Viju's care. He has to do what she says, to get maximum care and stay safe. If he is lucid, KV may not want to speak ill of Viju, for her sake, and for his own continued safety.

All I want is to know how he is doing, if possible speak to him give him my love.

The Basingstoke police assumed Viju would send me messages via social media informing about father's latest condition. They said however she has power of attorney and as KV is not competent, she can totally control what happens to him. They told me to speak to social services who can help, even if my father relies or private nursing assistance.

KV doesn't have dementia but can be physically unwell to the point all he

can do is lay down and take rest. KV strongly likes to be independent and is unlikely to give anyone power of attorney unless it is in the event he becomes helpless. If he is still lucid Viju would not have total legal control such as having a legal right to keep secret from me if something happened to my Dad. In fact a qualified solicitor can tell if Viju would have the power of total suppression of information if something happened to my Dad or he was comatose my Darling dad.

Of course Viju might suppress such things but offices are. What about you? Would you say it is a secret where KV is located? And why so Madam?

The authorities in Hants have said they will investigate my case as to why the social services in hands are saying that that they have to keep the information confidential about my father. There is no law require them to do so and it is in humane and it might be that the whole country hates me

The other thing is I have also been getting a spate of telephone calls from UK mobile numbers, sometimes at 2-3 in the morning. When I say hello, The caller says "madam are you available? What is your address. It seems someone in the UK has signed me up to an escort agency. It's some hateful people but I feel a widespread national hatred.

I have said a prayer that God to respect and honour my preferences; that my death shall precede any event whereby I must discuss my concerns with a female intimacy provider to women, mental worker or paid listener. It is not ethical to hurt and hurt someone & keep them isolated hoping the agonized victim will connect with mental workers.

Moreover if they threaten a psycho active injection unless I discuss with mental workers they might be able to "milk" me which is torture. It is also sexual misconduct, being a subversive action to lower me to females of a lower intelligence & substantially poor social background, where the help given by the intimacy-provider is anyway 100% bogus. Fraudulent equalization to promote one person's ego at the expense of another, the downgraded person being in a distressed situation so they can be stepped on easily.

A dastardly dishonest and unethical way to kill me in nearby Ireland well-concealed under a heap of illiterate women where my detention looks like something normal and above-board. I'm wondering if I can stand outside the British Embassy and protest. Not feeling well. Or might be able to get a portable chair and for this for an hour in a public park every day I don't know what good that will do.

I'm of what I said I am attaching what I sent the church but it's not an exact copy I've removed any comments I made it to them and corrected typos. I've also

attached a copy of my photo and my fathers to identify me as his daughter.

They have neglected my health. I am suspecting throat cancer. I have to be checked out urgently and they're not doing a damn thing. My eyes are killing me.

Main body

24 April 2023 OVERNIGHT AT BASINGSTOKE MAGISTRATES'

During this criminal conviction, there was one charge sheet by Viju and one by Steve. They were signed and dated at the bottom. Viju's was signed as Viju Wortley, and Steve's as Steve Wortley. however, I feel that if you did a handwriting analysis, you would probably discover that Steven Wortley did the signature of his wife, as both are in his handwriting. People said such a thing was physically impossible because you have to sign this statement in front of police at the police station.

If I made this up, or am mistaken? The other thing is whether a trumped-up conviction is physically impossible. in that case, you throw me and my story down the garbage can.

During the conviction, the police also gave me their charge sheet. They had interrogated me 5 days earlier using Viju's original allegations to the police. This charge sheet, a polished version of the initial interrogation, had deleted / changed the original questions that sounded absurd or that I could easily disprove. Also, Viju and Steve's charge sheets had been created AFTER this initial interrogation.

I also received some rambling files totalling around 60 pages as part of the charge sheet. All the above, and below events as described happened when I was detained overnight one-off at Basingstoke Magistrates and police station.

Viju's protection officer said Viju was telling her on the phone to call the Home Office right away.

These rambling files were handed to me by the lawyer who was helping arrested folks for free at the police station. The files included one-to-one private

emails I sent a male friend.

These emails discussed NOTHING connected to Viju Wortley but did have a historic real-life story involving my father and me. This made possible my potential suspicion that my father, who did not want such stories, once he found those communications, wanted me punished for them.

At the time the files were served, I was screaming and crying inside the room which had no windows, a low sloped ceiling so it was hard to stand up. I felt my father's letterhead was on the rambling email files. I thought my father had hacked me and printed out and given my private communications to Viju Wortley.

The next morning, the lady lawyer who worked that day at the police station showed me another file of my case of harassing Viju. This one she said was from the Pembroke Mental Health Centre. Based on its thickness, I estimated it to be 700 pages. I had not engaged with the Pembroke so this was stunning! (Months later she had said this file could not be found.)

That morning, I waited in a cell to attend the Magistrate's court. Viju's protection officer dropped me a deportation note. . A home office lady visited me in the cell. She apologized and left immediately, saying she had nothing to do with this case. Then the lady lawyer called me out and I would soon attend a Magistrates hearing. She said there was some talk of driving me straight to Heathrow airport after the hearing was over. She did not know immigration law, but would protect against that. She went to check that, and returned to say that was not happening. I went home to London in the train after the hearing.

UNHELPFUL LAWYER AND GUILTY PLEA ENTERED (9 May 2013)

I had a young Indian guy as a criminal lawyer. Now he scared me into saying only one word "guilty" at the hearing of another day. Basically, my fear pathology is very different from that of British females. He told me that if I said that, I would get away otherwise I'd get heavy punishment.

You can say I shouldn't be afraid of heavy punishment if I did not harass Viju Wortley. But I had already been battered and lied about at the initial interrogation(19 April 2013) where lies were shouted at me by police then told I was mentally incompetent, and asked to go home.

Now, I had used a non-religious word at my father's in 2010 over the phone(see bottom additional details) . There is more to this story, but the lawyer used that fact against me to say I would be very seriously punished if I didn't do exactly what he

I didn't know the A-B-C of criminal trials. I was to speak only one word "guilty". It is very important you don't say anything else" he said, I would get a caution and be let off

MY SECRET FEAR PSYCHOLOGY ASSESSMENT WILL NAIL THE INNOCENT

I am not understood in modern UK which is a psychology haven, because I am psychologically very different from British females. I know that UK have a special thing in distinguishing from females from men. Different measurements of an action depending on whether committed by a woman or man. UK's strong faith tells them psychology is a science.

You must excuse my fear these measurements may be unreliable like crystal-gazing. I dread to think what if a death sentence is given based on a psychology test where lay people practice face-staring, and make notes about face movements. I CANT TELL THE THE AUTHORITIES WHAT TO BELIEVE. I have MSc and traditionally, the science/university community do not count psychology as a science. THAT IS A FACT.

Other than a one-time guilty plea, my story wherever submitted has been consistent with no indication that I am guilty.

15 MAY 2013 ONWARDS AND CIVIL CASE AGAINST ME

On May 15th evening around 530pm, a white-uniformed man came to the front door. I was a very long white limousine parked on the other side. The man said he had waited outside my home every day for a whole month waiting for an opportunity to catch me without ringing the bell. He delivered civil papers for Reading County Court saying very big punishment was going to follow.

My sister's civil case 27 pages had stories disjointed from the criminal case. Here she had recreated my life history. I was sort of retarded since birth, she was brilliant in studies, the document said. Actually I was a gold medallist in my school leaving and I joined a competitive engineering college. That's not relevant but the civil case was full of malicious lies.

At one of my court attendances of Basingstoke Magistrates, the prosecutor said my sister Viju Wortley had sent a message through her that I would not harm a fly.

Whereas (just my opinion), the civil case to Reading County Court smelled of murder. I asked, and was refused permission to tape my Basingstoke court attendances at.

Actually on one of them the prosecutor at Basingstoke Magistrates made transcription errors, reading aloud April 19 as March 19, and said "On this day Mohini went out and killed her sister". There was no event on March 19 while April 19 was my initial interrogation and nothing else took place. Clearly the prosecutor had murder on her mind. I had to raise my hand to point out her mistake. Nobody else was concerned. I was more than traumatised. I went to Reading County Court in May 2013. Viju had a lawyer attend for her. He said that I was going to be squeezed dry of money paid to Viju.

The judge was neutral, but she said she had never heard of a civil case where someone wanted a band from 5 Counties and year of imprisonment if I disobeyed something like that.

The lawyer from Pitman's said he had been paid 6000 to attend this hearing. Viju paid extra to the court keep the hearing private so I had difficulty finding my hearing as it was unlisted. Afterwards, the lawyer said she was hiding on the 5th floor and he was going to get her and drive her home. Over Christmas Pitman's solicitors sent me Christmas wishes.

SENTENCING DAY AND AN ABORTED 6 MONTH JAIL SENTENCE 30 MAY 2013

By this time May was ending and I knew I had been wrongly advised about the guilty plea. I did understand at the time of saying it that I was saying I was guilty. I did not know the case went on trial if you pleaded innocent and if guilty you were just sentenced.

Other things happened to feel I would fare better without my lawyer no matter what.

I dismissed my lawyer the young Indian man just in time. I did not know though, that if I had not dismissed him, I was going to jail for 6 months on 30th May. That was the maximum punishment allowed by law for harassment without violence.

But the magistrates decided, because of my preceding request that he no longer work for me, and because he had petitioned for a mental incompetent, that I

This result in adjournments, eventually I was sentenced to 4 months on an electronic tag

PRE AND POST SENTENCING (8 JULY 2013)

After my sentencing on July 8 I was shaking and did not know about the appeal. I discovered rather late and they didn't give me right of appeal anyway nor the right to Subject Access Request.

I had tried retract that a guilty plea to innocent and was advised by a legal expert of my options. A £5000 psychiatrist was the answer. That "expert" would explain why I made the wrong plea.

Suitable only for the wealthy.

But I also saw a Catch 22 situation. Why would a not-guilty person, (if they were a millionaire) spend £5000 on a psychiatrist?

If I were not guilty, it's because I did not do the stated, not because a psychiatrist (heavily paid) said so!

My advisor said the psychiatrist would argue I use English differently. A argument that would lose, I felt. "Guilty" and "not guilty" have clear meanings that cannot be confused due to poor English. So I went to the sentencing unrepresented.

Viju never came to court, She never provided evidence of her allegations. It was just her story.

Viju's tale quotes me visiting her home alone on October 3, 2012. She made it look like my boyfriend did not come or wanted him out of the picture.

My mother Radha who died in 2022, said Viju told her she spent more £20000 on getting this conviction and could not disclose the exact amount. Radha said that during a fight with Viju the latter had said she was going to trump a murder charge against Mohini. Radha said she did not think Viju could put a murder charge on me. She was angry and shouted "do it" she said in 2015. She could not believe she could have given birth to that kind of girl, and said she has thugs at the Home Office. Viju has lived continuously in the Uk since 1981. Radha always said Viju was very abusive to her and sucked up to my father.

Also, I mentioned at the Basingstoke Magistrates, when I was detained overnight, a bunch of rambling files used as part of the charge sheet, which were not relevant in any way to Viju Wortley or her alleged harassment.

The male friend I who sent this email to, died suddenly within a year, under

When I was held overnight at the magistrates, my above-mentioned friend was still living. However I was traumatised from that day by the belief that my father's letterhead was on those files. That led me to believe he printed them out at home. That my dad had hacked my private communications and passed them to Viju, who would then collude with Basingstoke police to use them (without logic) to say I harassed her.

In January 2024 (recent) I asked my father, who was furious to learn I mistrusted him. "I have no letterhead on my printer" my father said. So I looked at those files again. I realised that the letterhead was of a Basingstoke police member, possibly Viju's protection officer Carla Hammond. This would indicate the hacker of the emails was Basingstoke police and not my father.

However my father's name or title was added to the sender line. THESE FILES ARE AVAILABLE FOR VIEWING. I think Basingstoke police added my father's name to the sender line I'm not sure why. This is something similar to what Viju Wortley did. She scanned one letter I wrote to a PC. She made it into a JPEG file, opened it on a print and deleted my date and signature. I mean you can add and remove information from a PDF by converting into a JPEG." See my mentally incompetent sister writes anonymous letters. It's a very low level skill to delete people's signature. I NEVER WRITE MY LETTERS ANONYMOUSLY.

I recalled how the police stalked me when I went on the train to Shifnal. Police came to his house in Shifnal. Police claimed "Your father has asked us to come and get you". My father denies this and now I know that the police had framed my father. They did not want me having my father's help.

Someone has signed me up as an escort in the UK using my mobile 07706 554261. One gave my user name on that escort site to be that of a wrestling magazine. This is a continuation of something started at The Institute of Physics who expelled me in 2006, calling me a man. I have left Physics.

MALICIOUS REFERRAL TO MENTAL HEALTH SERVICES

My father made a "malicious referral" to the Pembroke mental health centre in 2010 in an attempt to make me obedient. A senior Indian official, old as gold, he had little understanding of the modern British world, and did not realise his "harmless little prank" would take me to Yarlswood Removals Centre. Pembroke wrote me about the parental referral. Mr Jonathan Pearse (spelling incorrect) a mental health lawyer said mental health staff are liars and if they write an official letter containing legal threats, to ignore the threats and keep my distance.

That's my story. I feel anyone who thinks objectively isn't going to unequivocally side

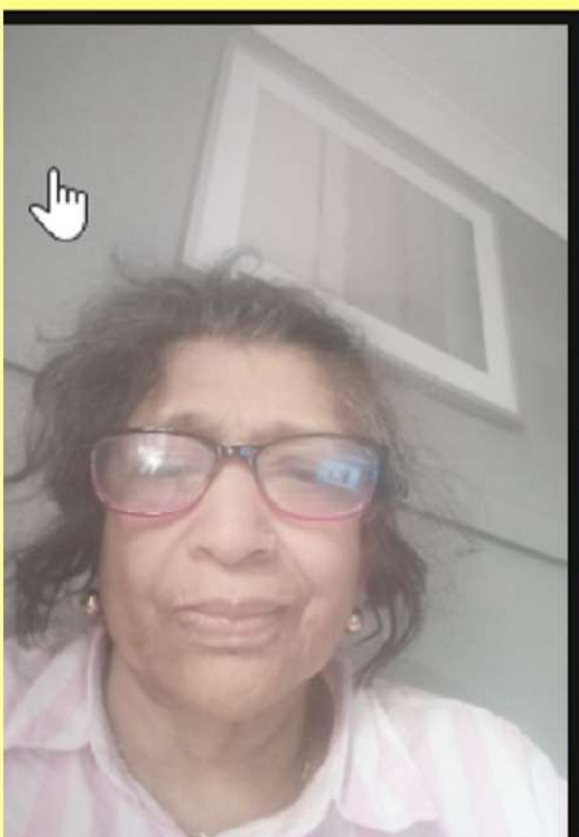

The kind pastor has told me in June 2024 that you Mrs Tidbury told him my father is alive, and unwell, and does not live at 19 Carston Grove.

Basingstoke police said trying to contact my father was a job for Hants social services. I emailed Hants social services in Mid may. They sent an auto-responder after that nothing. In the 7 weeks to follow I called them twice. Each time they said the team in charge of my father will email me back, but they can't say when. I know this is a lie.

An official said he will help but has not got back. Maybe he too went silent.

It is loads of women practising cruelty. I don't want to hear from Hants rotten services when my father dies. Instead -I have decided to wrap up before euthanasia.

I want worldwide publicity for my euthanasia. I am confident though of getting some publicity and euthanasia so I wont need to put up with this anymore.

The Theale GP secretary said in April 2024 she is not allowed to tell if my father is alive or dead. The GMC said to complain about this to PALS but the PALS lady did a disappearance act after initially exchanging emails for a month or two.

This gets spent in 2018 and lawyers said it is a petty one.
