In the first week of June, a pastor was able to verify that my father was still alive but deteriorating. He is not well enough to live by himself at his home at 19 Carston Grove, Ford's Farm, Calcot, Reading, RG317ZN 0118 941 5032. So he has been staying with my sister Mrs Vijayalakshmi Wortley DOB 19/06/1962 and her husband Steven Peter Wortley DOB 19/06/1963 of the Atomic Weapons Establishment at Mola.

The last time I spoke to my father was in the 3rd or 4th week of March when he said in a cracked-up voice he was at Viju's and was seriously ill. After that, his mobile +44 7757 491 353, and WhatsApp remained unanswered. Today this SIM card appears to have died which can happen to a SIM card that is not used or topped up in 3+ months depending on the network.

Hants social services have admitted knowledge of my father and since May 15 2024 have used dilatory tactics (I feel) by saying their care team in charge of my father will email me back but they cannot say when. After 6-7 weeks of them saying that twice on the phone, I began to feel they would NEVER get back to me.

A Tadley councillor was kind enough to contact Hants Social Services on my behalf. They did not take his call but when I called after that, told me my father's condition was **TOP SECRET** as my father had not given written authorization.

A Tadley councillor was kind enough to contact Hants Social Services on my behalf. They did not take his call but when I called after that, told me my father's condition was TOP SECRET as my father had not given written authorization.

My sister had a trumped-up criminal conviction against me in 2013 called harassment without violence. Never mind if my allegation that it was trumped up is true or false. This expired in 2018 but Viju has an injunction that she sworn is to remain for life. Viju has discretionary power over my entering the UK she swears to never annul. But her assistance is no longer wanted come what may.

This injunction – I can show it to you – does not include my parents including my late mother- who lived at RG317ZN and were not part of the criminal conviction.

It is not illegal for me to contact my father. He has to stay with her as he is not well now. He is our common father and I want to speak to him. if he is not well enough to speak I want social services to tell me how he is and give him my love. Viju has made it impossible for me to see my father and kiss him goodbye.

It is not easy for visitors to see Viju or my father. If social services do send nurses over, they would probably be the only people who enter. I heard that Viju's landline (which I don't know) is not manned, are there was some such announcement at the start of 2024 when my friend tried to find out if my father was alive. They have a large dog that barks at Intruders and I think most people are not welcome in their home as far as I understand.

I sent a registered post letter addressed to my father to Mala copied to RG31 7zn, around the 24th of April this year. The letter to Mala was rejected and signed by Viju Wortley using the initials VW. The same signature appeared on a second registered post which I sent only to RG31 7zn, signed for and accepted on the 11th of May 2024. It seems I checked immediately, but soon this signature was deleted from the Royal Mail website, which said my sister may have requested Royal Mail to give her privacy.

My sister does not wish me to know what happens to my father. In January and February of 2024, I could see my father was terrified of talking to me on the phone if she knew. She has always been a lady with no human sentiments.

I've heard the response of Hants Social Services. I am not asking for my father's medical or legal records. Those would require his written authorization. I am only asking how he is keeping. They feel they can't tell me if my father is alive or dead because that is illegal.

I seriously doubt that my father would have said not to tell me if he was alive or dead.

But going back to their reply that they don't have my father's written authorization.

Can I have a better answer as to why I am refused? You see my father did not have dementia or Alzheimer's when I spoke to him last. He would not have dementia or Alzheimer's in his lifetime as it is rare in our genes. But he can be physically weak or comatose.
