Dear Biyi Oloko,

I was unable to reach you by dialling your mobile after a long time. You were very supportive in March 2024 when I was trying to locate my father Mr Krishnaswamy Venkataramanan of 19 Carston Grove. He went permanently silent in March 2024, and went to Tadley Hampshire to stay with my sister Viju Wortley.

The latter has an injunction against me based on a trumped conviction of 2013 but this conviction did not apply to my parents. I had a right to contact them .

Viju who did not allow my father to speak on the phone till he died may have thrown away my letters and true to her nature failed to inform when Daddy died. She gave him the cheapest unattended cremation . Now daddy said he written his will for both his children after his days. But Viju who is probably executor of the will won't tell me anything about it.

I have attended Kennet Valley Free church twice as it gives me solace, shown fathers photo to the pastor. This church is next door to where my parents lived.

The odd thing is Hampshire county council kept lying about my father from May and they even lied to their local Tadley councillor Mr

Chatburn that my father was about to be discharged from a nursing home when he had already passed away. On 12 August the Councillor still thought my father was being evaluated for discharge or just got discharged based on what the hants social worker said.

I had started a formal complaint on July 25 intending to talk to the local social care ombudsman. On 9 August Hants county council emailed of his death on 1st August. He was not released from a nursing home. He was deteriorating in the nursing home so they moved him to hospital on July 20 and he died August 1st

If I knew my father was in hospital I would have come to hug and kiss him goodbye, as he was not with sister. That's what Hants social care kept from me and I feel they wanted to inform the day after his funeral.

When I got the email about my fathers death I felt sick in my stomach and had to come immediately to Carston Grove and the hospital where he died Basingstoke.

Theale medical centre secretaries had said in April it was illegal to let me know if my father was alive or dead as he had not given written authorisation. In fact one of my fathers ham radio friends visited his home 19 Carston Grove after his death to do a live and well check . The lady in house 20 gave deceptive information to that guy.

You had asked me to contact W Berks social care. I had done so. They were unfriendly but did not refuse anything. I felt they did not know my father who was living by himself semi independent

You were very kind and supportive so an asset to the community you serve

When my book is complete I will post you a copy to your office address and do not expect it to be read
