Dear Sir/ Madam;

My name is Mohini Hersom.

I was staying with my boyfriend in London after learning from Hampshire County Council of the death of my beloved father KRISHNASWAMI VENKATARAMANAN born 18.01.1934 resident of [19 Carston Grove, RG317ZN](#), who passed away on 1st August 2024. I had registered a formal complaint with Hampshire County Council, on July 25th.

I was talking almost daily with KV as my father was called, on WhatsApp in Jan and Feb 2024, when he said not to worry- he would never disinherit you because your sister Viju Wortley hates you.

The last I spoke with Mr. KV was in late March 2024, when his health deteriorated, and he went to live with Viju, a resident of Mala, RG263PA.

Viju has had a spurious injunction against me since 2013 which does not apply to my late parents. She will not inform me of Daddy's death nor the will. She has the power to do so as she knows the address and phone of my boyfriend in London and can also convey the message through Hampshire County Council Basingstoke police and my father's neighbours at RG31 7ZN.

On August 23, I wrote a registered post letter to the Newcastle Probate Office from London explaining why I would like to stop Viju Wortley from being granted probate. They replied to my Dublin address with a PA8A form and the letter I had written.

On September 19, 2024, I sent the completed PA8A back to them (Newcastle probate office) along with a postal order of £3 to HMCTS and the original letter I had written them on August 23, 2024. The tracking number was RL 009 755 777IE.

On 24th September 2024, this tracked post was picked up at Newcastle, and signed as "courts".

On 26 Sept 2024, I got email from newcastleprequiries@justice.gov.uk saying I need to complete the PA8A form.

On 30 Sept 2024, I telephoned 0300 303 0648 and someone advised that they could not find my registered post, which should have been sent to Leeds or Harlow. He wanted the form sent again to leedsdprequiries@justice.gov.uk.

Naturally, I cannot send postal orders by email. I can either pay over the phone or post this payment. If it helps, post the PA8A form again.

I have attached the Sept 26th email as well as the completed PA8A form I mailed on 19th Sept to Newcastle, along with the tracking slip and proof of delivery
