Also, for months, and when you lived at home, in 19 Carston Grove, your landline, rarely used, did not end in voicemail or keep ringing. I was talking to you on your mobile or Whatsapp daily or almost.

Starting around 20th March ,your Whatsapp was unavailable for a week.

I was not sure if your phone is turned out, or I am a blocked contact.

You have completely cut off contact. On 28th March Mrs Tidbury told a church pastor you are staying with Viju, and are well.

I also sent a snail mail letter to Agnes Slade. Her landline rings then cuts out, which I accept as permanent. Common sense tells me Agnes may be deliberately holding silence.

I have not time for mentally dependant women like that, users and consumers, who are infinitely protected by the law, and have no consideration for their fellow human no respect for man or God, knowing their society will rally up for them,

I also attempted to contact Doctors Mr. and Mrs. Rock who head Theale doctor surgery. Since Viju Wortley will not tell me how ill you are, I need you to give that surgery permission to let me know of your condition.

I trust and pray you are alive and well. I hope you are well enough to read this note.

I was a bit worried about you living alone in a 5 bedroom house. I hope Viju & Steve take good care of you.

I am sure Viju would not like you to speak to me. I want you safe and it is probably best for your safety if you do like she tells you.

I hope you understand I have only one Dad and it is nasty and selfish of her I am not allowed to speak to you.

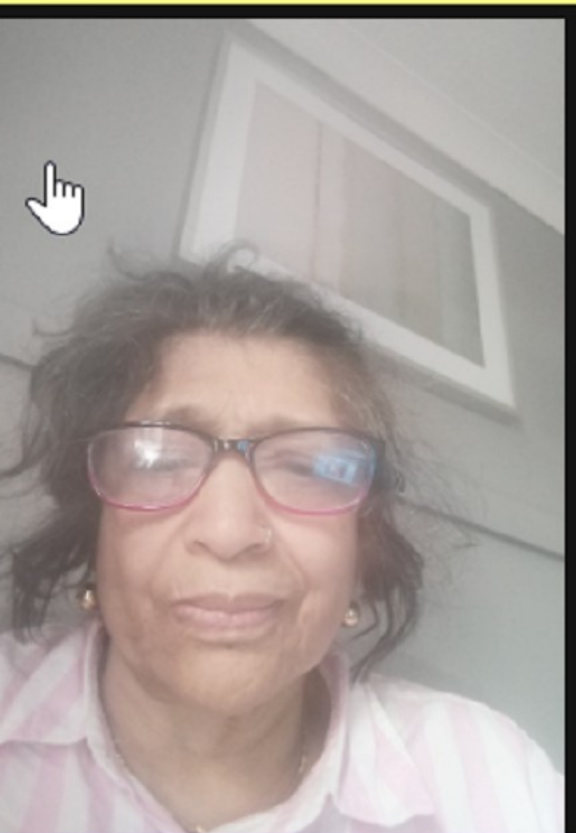
She is causing much distress and grief. I know you find this hard to believe but I am not a survivor who can withstand unlimited deprivation and abuse.
